The Fair on the Square is designated a “rain or shine” event, meaning that the event will take place regardless of weather. Event may be delayed allowing weather to pass, but unless the Huntsville-Walker County Chamber of Commerce cancels the event there will be no weather-related refunds or exchanges of booth rental.

Fair on the Square is an arts, craft and entertainment fair for the purpose of promoting business and trade in the local economy and encouraging visitors to our community. It is the policy of the Huntsville-Walker County Chamber of Commerce that no exhibitors who are representing any political party, candidates for elected office or political activities including voter registration may participate in the Fair on the Square. Any booths of this type will be prohibited. All participants purchase a booth for the event and all activity is intended to occur within the confines of the rented booth space (or other assigned area). There will be no marketing, promoting and/or advertising of any other business or service other than those who have paid to participate.

Refunds: All cancellations must be in writing. After July 31st, refunds will be contingent on the chamber reselling your booth and will incur a \$50 cancellation fee. Failure to be present at the event without adequate notification could result in loss of booth rental privileges for next year.
